Elements comprising a strategy



Element	Key Question
 Mission: 	Why does the Foundation exist? What is the value proposition?
 Vision: 	What does the Foundation become in the long run?
Goals:	What does the Foundation undertake?
• SWOT:	What are the strengths, weaknesses, opportunities and threads to reach the vision and goals?
 Initiatives: 	Which actions are done in order reach the goals?
KPIs:	How to measure the success of the initiatives?




The SWOT analysis is the starting point of the strategy discussion ...
